The Lumphanan Community Recreation Association (LCRA) committee hereby make the following rules and regulations to use the multi-sports court.

Committee member - means the LCRA committee member for the time being or any duly designated officer of the committee representing them or action on their behalf.

Sports Facility -

- 1. Nothing in these rules shall interfere with or prevent the execution of any duties of the committee member and any act of the committee member necessary for the proper performance of his/her duties shall not be deemed or considered to be in contravention of these rules.
- 2. No person shall be permitted to use the court unless a duly paid up member or authorised by the committee to use the court.
- No person shall, except with the consent of the committee members, bring into the court any bottle or similar container made of glass or other breakable material unless properly and adequately protected from the risk of breakage.
- 4. No child under the age of ten years of age shall be permitted or allowed to enter, remain in or use the sports court or any part thereof unless accompanied by and in the charge of a responsible adult member.
- 5. No person between the ages of ten and sixteen years of age shall be permitted or allowed to enter, remain in the court or use any item of equipment therein, unless having been specifically authorised by a appropriately qualified, suitably competent person or committee member.
- 6. The opening times for the Court will be 09.00 to 21.00 Monday to Sunday. Access to the court will be for 1 hour slots only. The court must be cleared and vacated at 21.00 at which time the floodlights will be automatically turned off.
- 7. Use of the court or associated equipment will be at the risk of the user or member. Any member or person incurring any injury will be responsible for their own safety. In the event of injury sustained by use of the court or any equipment the LCRA committee will not be responsible. Furthermore the committee will not responsible for any incorrect use of the court or equipment.
- 8. Any persons using the court will be responsible for providing their own first aid in case of any injuries.
- 9. No person shall enter or leave the court except by way of the duly appointed entrance or exit.
- 10. No person shall enter or wilfully remain within the court when the court is closed to the public.
- 11. No person shall, except with permission of a committee member, remain in or use the court when asked to leave by a committee member, whether in the event or an emergency or otherwise.
- 12. The committee members reserve the right to refuse entry to any person entering or wishing to use the court.
- 13. No person shall be permitted to use the court without prior payment of the appropriate charge, where applicable.
- 14. No person shall, except with the permission of the committee members, engage in any event or activity in the court unless wearing or using the equipment and clothing appropriate to that event or activity. Studded shoes or boots are **not** permitted
- 15. The entrance and exit shall be kept clear and unobstructed at all times.
- 16. No part of the court shall, except with the consent of the committee members, be used by any persons other than for the purpose which it is specifically designed or adapted for use. No equipment or fittings of the court shall be used otherwise than in accordance with the instruction of the committee members and no person shall cause or permit any unauthorised use of any equipment, fittings or other contents.
- 17. No person, without the consent of the committee members shall deposit or leave or cause to suffer or let fall or be deposited or left in the court:
 - i. Any substance or article likely to cause injury or damage to any person or property, or
 - ii. Any substance or article which might occasion risk of any kind to any child or other person finding or handling same, or
 - iii. Any waste or other harmful matter.
- 18. No person shall throw down, deposit or leave any rubbish, refuse, litter or paper of whatever description in the court, other than that in a receptacle/location provided for that purpose.
- 19. No person shall bring into the court any article or thing which, in the opinion of the committee members, would be likely to cause injury to any person or damage to the court or any part thereof of the equipment, fittings or other contents.
- 20. No person shall wilfully carelessly or negligently damage, injure, displace or remove any part of the court including a building, wall, fence, barrier, railing or any other fixture situated in or on or adjacent and ancillary to the court, or deface or

- destroy the same by cutting, writing or otherwise. Any person so doing will be held responsible for the cost of any replacement or repair.
- 21. No person shall wilfully, carelessly soil, tear, cut, deface, damage, injure or destroy any item or contents of the court. Any person so doing will be held responsible for the cost of any replacement or repair.
- 22. Any person who is either in a state of intoxication or under the influence of drugs in the opinion of the committee members shall not enter or be allowed to remain on the court and shall remove themselves upon being requested to do so.
- 23. No person shall consume any spirituous or intoxicating liquor in the court.
- 24. No person shall take, sell or distribute drugs in the court or any part thereof except in a case requiring first aid treatment where the administering of drugs is necessary and performed by an appropriately qualified medical practitioner or there the drugs are taken as part of a prescribed course of medication.
- 25. The production, consumption or sale of food and drink in the court by user/member is not permitted except with the consent of the committee members. With the exception of water for re-hydration purposes.
- 26. No person shall smoke in any part of the court.
- 27. No persons shall, except with the consent of the committee members, display, affix, or post any bill, placard or notice upon any part of the court or distribute any bill or other written or printed paper in the court.
- 28. No person shall, except with the prior consent of the committee members, sound or play any musical instrument, sing or perform or operate any radio or television receiver, record player, tape recorder or other sound producing device in any part of the court.
- 29. No person shall, except with the express verbal and/or written consent of the committee members, and subject to any rules of copyright which may exist, take any photographs or films, or any recording by any means whatever of any event or activity taking place in the court.
- 30. No person shall cause or permit a dog or other animal belonging to them or otherwise under their control to enter or remain in the court unless the dog is a working dog in use by a registered blind or deaf person or as part of a specific let authorised by the committee members, except where the supplementary rules provide to the contrary.
- 31. No person shall behave in a disorderly or offensive manner in the court or use violent, abusive or obscene language therein, or prevent the proper use of regulation of the court.
- 32. The committee members cannot accept responsibility for any person who has been injured within the court whilst engaged in authorised or unauthorised activities, or activities that contravene any of the aforementioned rules.
- 33. No person shall wilfully obstruct, disturb, interrupt or annoy any other person during proper use of the court, or wilfully obstruct, disturb or interrupt the committee members in the performance of his/her duties.
- 34. Every person shall observe any reasonable instruction that may be given by the committee members.
- 35. Any person who on being required to leave any part of the court by the committee members who has reasonable grounds for believing that the person has contravened, is contravening or is about to contravene any terms and conditions applying to the court, fails to leave shall have their membership revoked.
- 36. The committee shall be at liberty to revise, alter or dispense with any or all of these rules when they see cause, and to enact others in their place.
